We may collect, hold and use some of your personal data and this sheet will provide more information about how this works.

1. Definitions and Interpretation

Meanings of phrases within this document:

3. Users Rights

4. **Data Collection**

5. **Using Your Information**

We will delete your personal information once your request has been met or the service has been provided, except where –

- You were interested in details of properties we are offering, when we will continue to hold your information in order to send you information on other properties that may interest you;
- You become a buyer of a property;
- You require us to retain it for longer;
- We are required to retain it for longer for other legal reasons.

You have the right to withdraw your consent to us using your data and to request that we delete it.

We will not share any of your data with any third parties for any purposes other than for the purpose of the purchase of the property.

6. **Storage of your Data**

Your data will only be stored in the UK.

7. **Accessing Your Data**

You have the right to ask for a copy of any of your personal data held by us (where such data is held). Under the GDPR, no fee is payable, and we will provide any and all information in response to your request, free of charge within 30 days. 8. **Changes to our Policies**
